General Information

BRANDT SMART TRIO is specifically formulated for foliar delivery of manganese, zinc and boron for all crops.

Foliar Application

Ground: Apply 1-2 quarts in a minimum of 10 gallons of water per acre as needed.

Aerial: Apply 1-2 pints in a minimum of 5 gallons of water per acre as needed.

Soil Application

Use 1-3 quarts in a minimum of 10 gallons of water per acre. Not for use with starter fertilizer.

Mixing and Handling Instructions

Put 1/3 to 2/3 of total desired water volume in tank. Add adjuvant(s) and pesticide(s) if desired and agitate until thoroughly mixed. Add desired amount of BRANDT SMART TRIO and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is a good field practice for evaluating compatibility of multiple chemical mixtures. Caution: Check compatibility with chemical mixtures and high phosphate and alkaline (high pH) solutions.

For full strength application, handling or storage equipment **MUST** consist of either PVCs, polypropylenes, most plastics, or stainless steel. Never use mild steel, nylon, brass, aluminum or copper around, to store, or to handle full strength BRANDT SMART TRIO. Rinse handling equipment after use if material is susceptible to corrosion.

The use of an adjuvant is recommended. Performing trials with adjuvants may be useful in determining the best inclusion rates for optimal performance. Optimum rate of application will vary depending on soil properties.
